Royalties on books sold are set by publisher as a percentage (typically 15%) of retail price of each book sold and is contingent upon publication and printing costs. Royalties will be set for each book to be approved by author and Apprehending Truth Publishers before publication.

Direct from Publisher - Author pricing for books purchased by the author are typically 40 - 50 % of retail price. Retail prices are set by the publisher before publication. Royalties are not earned on books purchased through the "Direct from Publisher" program.

Each book will receive a Publication Data Sheet outlining pricing, costs and royalty information. Authors retain all copyrights, unless otherwise stipulated, and remain free to republish or amend their works as they will. The unique ISBN number is linked to the publisher and cannot be reused.
